INSTRUCTIONS FOR THE CANDIDATES

1. Category wise Distribution of Seats

The admission to first semester of LL.B. (Three-year course) will be done for 300+30 seats for University Law College. The category wise breakup of total seats for admission is as follows: -

2. Minimum Eligibility Requirements

All the candidates who are appearing for counseling for ULET-2025 are advised to ensure their eligibility as provided in the University Prospectus available on University Website.

- Unreserve Category: Minimum 45 percent marks in the qualifying examination (UG/PG). If candidate is from outside Rajasthan; Minimum 60% Marks in the qualifying examination (UG/PG).
- OBC/ST/SC/PH Category (domicile of State of Rajasthan): Relaxation as per the University Norms.

3. Fee Structure

- The admission fee will be deposited only through online mode. The candidates are advised to come prepared accordingly.
- The Candidate has to deposit the admission fee **online through ICICI bank portal** on university website on the same day of the seat allotment after counseling.
- An additional amount of Rs. 100/- in cash shall be charged for admission form at the time of admission.
- The admission of a candidate will be valid only after submission of copy of fee deposit receipt at University Law College, University of Rajasthan, Jaipur on the day of counseling.
- Fees once deposited will be refunded only as per University Norms.

- Category wise seats will be filled through Counseling in order of merit as per the schedule. In case, a candidate is absent in the counseling his/her seat will be filled by the next candidate of the same category in order of merit present on that day. No Second chance will be given to such candidate in the counseling for University Law College, University of Rajasthan, Jaipur. Counseling will close after allotment of category- wise seats.




5. In case where two or more candidates have secured same marks in the final result of ULET 25, the preference shall be made to the candidate on the following criteria in descending order:
 - a) Who has secured higher marks in ULET 25 without any weightage.
 - b) Where above criteria are unable to fix the preference, the candidate who is older will be considered for admission
 - c) Where above criteria are unable to fix the preference, who has secured higher marks in Graduation examination.
6. The Candidate has to be present himself/herself personally before the Counseling Committee as per the schedule.
7. No person shall be allowed to enter the Counseling Centre apart from the candidate himself/herself and no other person (e.g. parents, relatives, friends etc.) shall be allowed to take part in the counseling process on behalf of the candidate.
8. Candidates must note that participation in counseling does not guarantee the admission as more candidates than the numbers of seats to be filled are being called for the counseling.
9. Any candidate, who is eligible for admission in the University Law College as per the merit, but he/she is interested in taking admission in University Law College Centre-II (SFS Course) has to give an application in this regard to the Convener, ULET 2025 at the time of counseling

10. List of documents required

The Candidate has to bring following documents in original and two sets of self-attested photocopies of each document on the day of counseling:

- iv. Post-Graduation Marksheet (if applicable)
- v. Senior Secondary Marks sheet and Certificate
- vi. Secondary Marks sheet and Certificate
- vii. Category/Caste certificate as applicable issued by competent authority as directed by state government. Please note that following category certificates will be valid:
 - a. OBC/MBC certificate issued on or after 01/07/2024
 - b. EWS category certificate issued on or after 01/04/2025
- viii. Certificate of Person with disabilities/Differently Abled from the competent authority.
- ix. Original Weightage certificate as issued by competent authority
- x. Transfer Certificate & Character Certificate from the institution of last regular course.
- xi. Recent 06 (Six) passport size photographs. (Kindly note that the Photograph must match with the photograph uploaded with ULET 25 application form)
